**Rabbi Michoel Gourarie** is the founder and director of Bina, an adult educational organization and Rabbi of the Shtiebell Synagogue. He was educated in the U.S and received his Masters of Education in Sydney. He is known as a passionate educator who lectures on a wide range of topics with special emphasis on personal growth and self development including self esteem, communication and relationship building.



**Assistant Commissioner Mark Murdoch, APM** joined the NSW Police force in 1980 and in August, 2010 was appointed Commander, Central Metropolitan Region. He is the Police Corporate spokesperson for Domestic and Family Violence and represents NSW in various related agencies.
